

How would you rate the conference in general?



























Negative

- Some confusion/ misunderstanding in the media about the difference between the two events
- The exhibition area was not very visited
- Media Advisor did a substandard job
- Confusion in registrations, due to the fact that participants had to register separately for the two events.



- Consider charging admission
- Consider increase the number of physical participants
- Return to a two-day event
- Solutions to attract more participants to the exhibition area
- If it is again held jointly with the GGIF, it requires more coordination of logistical and communication aspects.
- Take more advantage of event platform and existence of dedicated staff to manage it
- Ensure that all registrations are subject to confirmation
- Invest in other types of initiatives such as pitching sessions to achieve more "tangible" results
- Earlier coordination of stage design
